This will result in more material being recycled/reused and less going back into landfill.</li> <li>Further recycling plant upgrades, ready for operation at end of 16/17 financial year. Increasing the efficiency of the overburden processing.</li> <li>Initial screening rates indicate that Stage 1 (Cell 1AX and 1B) overburden processing is being completed at 400 tonnes per day, at peak processing.</li> </ul> <p>WLR have acknowledged the environmental concerns sensitive to the community and have begun overburden processing in cells with less overburden in order to refine the process, therefore limiting the environmental impact to the community.</p> <p>Cell 5, consolidated and vegetated is considered to be a low environmental risk to the community at this stage.</p>
