ITEM 1. WELCOME (Catherine Botta)

The final notes from the June 2023 meeting are available from the **Brooklynip website**.

Catherine Botta (Convenor) conducted acknowledgement to country and welcomed everyone to the BCRG forum and those online.

Cath reminded everyone of the purpose of the forum – to foster collaboration between members of the community, industry, EPA Victoria, local and state government. The focus of this forum was air quality.

Everyone was invited to introduce themselves.

ITEM 2.

ROLLING ACTIONS (Andrea Mason)

Andrea Mason, Executive Officer, BCRG reminded everyone of the Rolling Actions list which records actions from each meeting and updates actions that have been addressed between forums. These are available on the <u>Brooklynip website</u> and are circulated with the enews.

The status of the actions from the previous meetings are:

ITEM 3.

COMMUNITY UPDATE (Bert Boere, Brooklyn Residents Action Group and Geoff Mitchelmore, Friends of Lower Kororoit Creek)

The full presentation from Geoff and Bert is available in <u>Attachment 1</u>.

Geoff provided detailed plans on the community vision for the entire Zone 9 Pipeline Reserve to be complete by end 2024 if all the agencies worked together.

Projects include:

- Brooklyn Urban Forest
- Pipeline Reserve Western, Central and Eastern precincts
- Melbourne Water pondage including heritage sewer
- Honourable Melissa Horne MP, \$5,000,000 to clean up dusty roads in the Inner West.
 - o Brimbank is to receive \$1,670,000 to seal Old Geelong Road
- Land transfer from Dept of Transport to Pipeline Reserve along Old Geelong Rd
- WGT proposed offsets tree planting
- Cleanaway to Geelong Rd Concept East WGT grants.

Bert provided an update on the new Brooklyn Community Hall which BCRG used for the first time at this meeting. It was a result of strong community lobbying. There will be a new hybrid model for the hall management between community and council. He thanked all those involved.

Bert also emphasised the ongoing dust issue for residents based on personal experience including excessive dust and mud on homes creating not just a nuisance but potential hazard. He is hoping measures in the long run will help to improve this issue – the community has been talking about it for 20 years now.

ITEM 4. COUNCIL UPDATE (Francesca O'Brien, Senior Coordinator, Environmental Sustainability, Maribyrnong City Council)

Fran provided an update on Maribyrnong's commitments and actions for improved air quality. These included:

- Tri-council air quality forum in early 2024 (Brimbank, Hobsons Bay and Maribyrnong)
 - o Include key stakeholders and experts local government, universities, agencies
 - o Goal to create an agreed short list of actions
- Community education campaign
- Air Quality Improvement Plan
 - o 75% of recommendations actioned or completed
 - o Health Emergency declaration March 2023
 - o Treeplanting, walking paths, transport and vehicle usage
 - o More air quality sensors with RMIT

- Advocacy
 - o Writing to government to highlight the issues
 - o EPA grants for businesses
 - o EPA environmental health tracking program
- University research projects

Action 0811_1: MCC to provide the detailed table of actions in their Air Quality Improvement Plan-Maribyrnong.

After the meeting: The table of actions can be downloaded here: Air Quality Improvement Plan - Maribyrnong

QUESTION: Does the environmental health tracking include human health?

Action 0811_2: MCC and EPA to respond to whether the environmental health tracking includes human health.

QUESTION: What metrics are you tracking with the air monitors?

Fran: The air monitors are measuring dust particles. There are 7 monitors in Maribyrnong. Other metrics for monitoring is yet to be explored.

COMMENT: It would be better if BCRG presenters made the correlation between the facts from the data presented and the actions being undertaken to address the issues.

COMMENT: Conversations are underway with RMIT to undertake a before and after "Healthy Liveability' study on the work being done with Federation Trail

ITEM 5. COUNCIL UPDATE (Arthur Vatsakis, Hobsons Bay Council)

Arthur was an apology and sent through the following information via email which Cath read to everyone.

By way of update, here is what I was intending on providing to BCRG:

- Following the Air Quality Forum, Council is finalising the Draft HBCC Air Quality Action and Advocacy Plan. We intend on presenting this to the Councillors at an upcoming Council meeting likely in the new year.
- As part of the review of the Industrial Land Management Strategy and Guidelines, we are intending to incorporate air quality objectives and guidelines for future land uses and development. In these documents.

ITEM 6. COUNCIL UPDATE (Kristen Gilbert Manager City Planning, and Matt O'Mara, Coordinator Planning Compliance, Brimbank City Council)

Kristen and Matt provided a short commentary on sites in Brooklyn that Brimbank City Council are actively pursuing with regard to compliance.

Current planning permit applications

No new planning applications received since the last BCRG.

Current applications that haven't been determined are:

- 20-24 McDonald Road Brooklyn use of the land for trade supplies application received in April 2023
- 457A Somerville Road Brooklyn use and development of land for materials recycling (industry) with ancillary shipping container storage and vehicle storage facilities still waiting on additional information from applicant.

Decisions made since last meeting

- 554 Geelong Road Brooklyn internal works to existing gym and addition of signage amended permit issued in July 2023
- 174 Old Geelong Road, Brooklyn use of part of the land for materials recycling refused in June 2023

VCAT decision

• 696 Geelong Road Brooklyn – an application for construction of a front fence was refused by Council on the basis that we believed that they should be also seeking a permit for the other works that had been undertaken without a permit. VCAT disagreed and issued a planning permit in July 2023.

We then lodged an Enforcement Order application at VCAT for use of the land without a planning permit. A practice day and compulsory conference have been held but the final hearing is not until the end of January 2024.

Current compliance activity

- Proactive dust monitoring program several of the operators within the Brooklyn area are being monitored for dust control measures where it was required as part of their approvals. To be conducted in higher temp and higher wind days.
- Western end of Old Geelong Road looks like some trailers are again being stored within the road reserve. We will be working to have these removed
- 720 Old Geelong Road Brooklyn still working with the owners to have the site cleaned up and brought into compliance with the Planning Scheme
- A number of properties within Brooklyn investigating unpermitted uses and non-compliance with planning permits. Nothing specific to report at this stage.

QUESTION: Can you provide an update on the 730 Old Geelong Rd where the tankers were being stored?

Kristin: Council is waiting for a permit application from that site – they are currently operating without a permit.

Sarah Connolly MP: Thanks to community advocacy, I invited Brimbank CEO Fiona Blair to view this site to show her the issues. I urge community members to reach out to your representatives to advocate any issues they face.

QUESTION: Was an application for a second concrete crushing unit ever approved?

Kristin: Question was taken on notice.

After the meeting: After a review of applications over the last 2 years it was found that no applications have been made or approvals issued for additional concrete crushing units.

ITEM 7. EPA VICTORIA UPDATE ON DUST, NOISE AND ODOUR PROGRAM (Gary Laidlaw, Senior Engagement Lead and Sam Sparks, Team Leader, Western Metropolitan Region)

The full presentation from EPA is available in **<u>Attachment 3</u>**.

Gary and Sam provided an update on the air quality, odour and compliance data including for Footscray, Laverton North and Brooklyn.

Dust and Odour

- There have been no PM10 dust exceedances this FY,
- Odour reports have begun to flatten off and were down to 13 for October,
 - o Communications continue with Australian Tallow Producers (ATP) and Cedar Meats,
 - o Increase in reports related to JBS Australia from Yarraville residents,
- There were very few complaints received from Laverton North averaging 5 per month.

Resource Co Update

- On 15 September 2023 EPA received a development licence application from ResourceCo for their proposed soil washing facility at 125 Bunting Road, Brooklyn.
- As the application was not complete, EPA requested further information.
- When EPA receives the information requested from ResourceCo (likely in November), the application information will be reviewed for its completeness. If the application is found to be complete, then EPA can accept the application for assessment.
- Once accepted, the application will be made available for public comment via the online engagement platform <u>https://engage.vic.gov.au/EPA</u>
- Traffic level considerations are out of the scope of the EPA assessment.

Compliance

Other Activities

- **Better Environment Plan** (BEP) EPA received the BEP scope from the Brooklyn Recycling Group (Sunshine Groupe, City Circle Recycling, ResourceCo and Delta Recycling) on 1 September.
- Christian Buxton, Sunshine Groupe, added that the BEP provides a group of industry members to meet and develop a plan to address particular environment outcomes – in this case, a focus on air quality. They have spent 2 years working with EPA to agree to practices and outcomes for this plan and those businesses will make a public commitment to deliver those practices and outcomes.
- Brad Lemmons, ResourceCo added that the BEP is an important collaboration and innovation which aims to raise the bar for industry to improve as a group and provide leadership.
- EPA marks International Day of Climate Action, 24 October, 2023.
- Next community conversation drop in December 5.

COMMENT: The particulate PM10 information shown in the Air Quality graph are an average figure over a 24-hour period and do not show the spikes in particulate pollution levels of PM10 during business hours which are often over 100 μ g/m3. Also particles over PM10 should be measured as these have a serious impact on our health and amenity. Air monitors placement is important to capture these.

QUESTION: How does EPA assess licence applications and how do other prescribed agencies get involved?

Sam: EPA has an Environment Public Health Unit which engages with the relevant experts e.g. odour, dust and public human health to assess the applications. When necessary EPA refers to the application to the relevant agency.

QUESTION: What has the Brooklyn Recycling Group achieved to date with the Better Environment Plan (BEP)? At what point will we know the plan and the measurable outcomes to report?

Christian Buston: Each business runs their own dust improvement plans and have been in ongoing discussions with EPA on what needs to be addressed. The BEP provides an opportunity for innovation and working together to find solutions. The BEP is a new vehicle and is still being developed with consideration to legal implications – it is a time-consuming process. Hopefully the draft will be available in the new year – dependent on EPA. Sunshine Groupe is committed to present the actions we are doing.

Action 0811_3: Brooklyn Recycling Group to update BCRG on progress, deliverables, legal implications for the Better Environment Plan (BEP).

QUESTION: Are there works being undertaken on the Brooklyn monitoring site?

Bert Boere: Upgrade works are going on with Brooklyn station but no detail of what.

Action 0811_4: EPA to update what the monitoring stations upgrades are for.

QUESTION: Is EPA able to provide the raw hourly data from the monitoring stations?

Sam: EPA can provide the raw data on request however its relevance depends on what the equipment is measuring. EPA's response to dust emissions from industry sites still requires the businesses to reduce any dust emissions - despite the data shown here in BCRG.

Sarah Connolly MP: The hourly data would be important information for government to utilise.

COMMENT: We still have the same problem with dust that we have had since 2009.

Action 0811_5: EPA to investigate providing hourly monitoring data to BCRG including back to 2009.

QUESTION: Where is the EPA's mobile monitoring unit and can it be used to monitor Brooklyn sites?

Jim: The unit was designed to monitor fire and smoke emissions. It was trialled in Brooklyn but not used for that purpose.

Action 0811_6: EPA to investigate if data from Brooklyn can be 'live' on the website.

ITEM 8.

INDUSTRY UPDATE (Jim Demetriou AOC Specialist and Leighton Black, Site Manager for Australian Tallow Producers)

The full presentation from ATP is available in **Attachment 4**.

Jim, an independent air and odour compliance specialist and Leighton from ATP gave an update on the operations at the ATP Brooklyn site and improvements to minimise the impact to the community.

These included new asphalt across the site to reduce dust and the biofilter rebuild to process and reduce odour emissions.

Jim outlined the process by which he independently audits the site for odour including unannounced site visits. The site audits identify effective odour management systems and areas for continual improvement. Assessments are made daily by ATP and monthly by Jim.

Areas for improvement identified:

- Building sealing
- · Performance reviews of biofilters and balancing processes
- Audits assess day-to-day performance and with a focus on continuous improvement actions
- Goal is to minimise odour emissions and protect the community.

Community Noticeboard

ATP has developed a new website portal for reporting and to keep the public up to date on progress and any necessary operational changes or maintenance programs that could have an unintended impact.

There have been no reports to the noticeboard to date and Jim hasn't picked up any odour himself off site in recent months showing improvements. There have been some reports to EPA alleging odour from ATP. Unfortunately, the reports from EPA come through to ATP up to 2 months after the event.

COMMENT: There needs to be more done to promote the noticeboard to the community e.g. the Brooklyn community Facebook page.

Sam Sparks, EPA: As part of the new Act, EPA is encouraging businesses to create reporting on their websites to help mitigate the delay in response from the EPA reporting system. It is hoped that this will result in a faster response time for the businesses to address any issues.

QUESTION: What is Jim's role as a consultant in identifying odours and their source in Brooklyn?

Jim: I am contracted to ATP to assess and make recommendations to improve the odour emissions from their business. I am not compelled to trace other odours in Brooklyn not coming form ATP. I am happy to share my information with EPA on request.

COMMENT: The community is tired of reporting and the ATP site is just an extra level of reporting for us when we are already reporting to the EPA site. If there is odour during the night I am not able to directly contact the company at that hour to report the odour.

Action 0811_7: BCRG to share the ATP Community Noticeboard information to Facebook.

After the meeting: The ATP community noticeboard page has been posted on the Facebook pages as requested by a resident at the meeting. @brooklyncommunityrepresentativegroup and @brooklyncommunitygroup.

ITEM 9. INDUSTRY UPDATE (Brad Lemmon, CEO, ResourceCo)

Brad Lemmon was joined by Ryan Craig – Site General Manager, Steve Harrison – CEO – Soil Re-use and Recycling, Steph Holland – Strategy Delivery Manager from ResourceCo.

Brad introduced ResourceCo, the business and the current operations at the Brooklyn site since taking over from Sunshine Groupe in December 2022, and the process for community engagement in relation to their proposed soil washing plant and permit application.

He began by acknowledging the community concerns regarding the new proposal for a soil washing plant and that the community engagement through the letter to residents had raised some interest. He stressed that ResourceCo's approach involves having positive and clear engagement with the whole community.

About ResourceCo

ResourceCo is a private business established in 1992 as a crushing and demolition business but have since evolved into an integrated resource recovery business operating across Australia and parts of Asia. It has a clear purpose to take waste materials from building, construction and other sources such as tyres and to convert them into high grade product for reuse, fuel and energy sources. They have a strong ethos on landfill diversion and carbon abatement and have diverted more than 60 million tonnes of waste from landfill since their inception in 1992.

Brad recognised that their operations strive to have no impact on the community and that there is a strong emphasis across all their operations to achieve this outcome.

Brad: ResourceCo acquired the business in Brooklyn approximately 12 months ago. It provides a fantastic opportunity to plan to improve the facility to address community impact. The soil washing plant requires a significant capital investment and will include many improvements that will improve amenity impacts. Dust mitigation is important and will be addressed by continuing to implement dust monitoring and improvements at the site.

Community Engagement and Actions

Brad outlined the approach to community engagement for the soil washing permit application.

- ResourceCo plans to take as much time as necessary to address community concerns.
- Acknowledges that there was a false start to community engagement through the letter to residents.
- They intend to work closely with EPA and council to confidently demonstrate commitment to compliance and community concerns.
- The aim is for improving and reducing any impacts on community and potentially creating positive impacts in the future.
- ResourceCo will start providing updates on any site improvements.
- ResourceCo has joined in with neighbouring businesses to deliver the first Brooklyn Better Environment Plan seeing this as a great initiative and opportunity to develop innovative solutions.

- Plans are in place for enhanced dust monitoring, education and training for personnel onsite to manage any potential impacts to community.
- The EPA Development Licence Application for the soil washing plant is not expected to be advertised on Engage Vic until early 2024.
- ResourceCo will be establishing a community engagement process to gain a deeper understanding of the community concerns regarding the soil washing plant and other issues. They hope that this will provide an opportunity to listen and address or mitigate these concerns. Expression of Interest forms for community members to a CRG were available.

QUESTION: Why would you set up in the location within 7 kms of Melbourne's CBD and not outside the metro area? There has been no real change in Brooklyn for 30 years with regard to dust.

Brad: The materials to be processed are being generated close to Brooklyn and will already be transported throughout the community. The community concerns regarding dust are legitimate. ResourceCo will be investing in the best practice European equipment to be installed which will enable a wet process for the soil washing with no dust generation. Receival and tipping of materials will be into a closed shed facility and enter an enclosed conveyor to be washed and graded. The remaining approximately 10 – 20 % of soil will compose of contaminants that will be sent off site for appropriate disposal.

COMMENT: The community has a high level of mistrust around companies promising to comply with licence conditions or regulatory conditions. We don't accept you won't emit dust and the operation doesn't seem to be complying now. You act as though you will get the licence.

Brad: This is not just about compliance – our intent for the whole operation is to operate at the best level we can and show leadership. Your concerns are important and we acknowledge those concerns.

QUESTION: You say you are trying to work with public which is great. What checks are there for the mechanism and feedback loop for monitoring dust emissions and will you have to log it with EPA and council?

Brad: Resource Co will maintain a Community Complaints Register and ensure there are time limited responses to those complaints in the register. There is also a need to protect the health and well-being of the staff on the sites which should also protect the community.

Sam Sparks, EPA: There is a legal requirement that businesses report any licence breaches to EPA as soon as practicable - at which point the issue should already have been rectified.

QUESTION: What will be in the soil you washed?

Steve: Any contaminants are washed into the final silt product which is collected and sent to be appropriately disposed of in landfill. They are generally low-level contaminants from the Melbourne Inner West region.

COMMENTS: The community is concerned about the growing amount of traffic from West Gate Tunnel – over 11000 trucks per day plus your trucks coming into Brooklyn. In NSW this is not done in city areas – so why in Melbourne? With over 2400 tonnes to be process per day – PM2.5 emissions from truck traffic to and from the site is also an issue.

COMMENT: The closest residential building is 400m from ResourceCo. The Altona soil plant has a buffer level at greater than 950m set by VCAT and the State regulation is set at 500m.

Brad: The Altona soils plant is a different type of processing plant where the soil received have higher contaminant levels with a thermal destruction treatment process with some emissions which has a different set of criteria. The Brooklyn plant will have no emissions of odour, particulates, dust or gas. All the processing will be in a contained process resulting in clean soil for re use. Hoping to address these in future.

QUESTION: How will information regarding the mitigation processes be communicated to the residents? How will potential pollutants and appropriate monitoring be identified for the process?

Brad: Under current licence required to undertake dust monitoring. Under the BEP process we are exploring enhanced monitoring. No dust to leave the site.























STATE BUDGET 2023

ResourceCo Development Licence Application (APP025507)

On 15 September 2023, EPA received a development licence application from ResourceCo, for their soil washing facility at 125 Bunting Road, Brooklyn.

As the application was not complete with all the necessary information, EPA requested further information from ResourceCo on 19 October 2023.

When EPA receives the information requested from ResourceCo (likely in November), the application information will be reviewed for its completeness.

If the application is found to be complete, then EPA can accept the application for assessment.

Once accepted, the application will be made available for public comment via the online engagement platform: <u>https://engage.vic.gov.au/</u>

EPA must decide on a complete development licence application within four months of receiving it. However, this timeframe can change if EPA needs additional information to make a decision.

In assessing the application, the EPA will take into account potential impact on human health and the environment and submissions from prescribed agencies and other interested parties.

Traffic level considerations are out of the scope of the EPA assessment.
